Overall outcome

The school is likely to meet the relevant independent school standards if the material changes relating to the school provision are implemented

Main inspection findings

Part 1. Quality of education provided

- The proprietor currently provides full time education for up to 30 pupils, aged 13 to 16 years, all of whom have special educational needs and/or disabilities (SEND). The proprietor proposes to increase this provision to offer full time education for up to 60 pupils aged 11 to 16 years. It is expected that all further pupils will have education, health and care (EHC) plans, as is currently the case.
- Curriculum plans have been carefully considered to ensure that they are adaptable to individual needs, aptitudes and abilities. Assessment has been designed to allow rapid identification of gaps in knowledge on entry and over time. The proprietor has recognised that some pupils need additional support to become fluent readers and has established a suitable phonics programme to facilitate this.
- The school provides a broad and balanced curriculum which includes the seven aspects of learning set out in the independent school standards. Teachers know their pupils well and ensure that the curriculum is adapted to focus on the gaps and/or misconceptions that assessment has identified. Constant reinforcement and reaffirmation of their achievements in lessons supports them to move on in their learning. Pupils are well-supported to prepare for their next steps into education, employment or training.

- The proprietor has ensured that there is a comprehensive and well-considered programme of personal, social, health and economic (PSHE) education in place. Pupils have many opportunities to learn about other cultures, religions and beliefs and they are offered a broad range of experiences to help them develop their understanding of the wider world and what it can offer.

- The proprietor has ensured that an age-appropriate policy for relationships and sex education (RSE) is in place. Prior to its implementation, parents were consulted and informed of their right to withdraw pupils from sex education.
- These standards are likely to be met of the material change application is approved.

- Teachers and leaders place great store on ensuring that pupils have a high level of support to build their self-esteem and confidence and to become more resilient. Well-qualified teachers ensure that pupils' learning starts with what they know, addressing gaps and misunderstandings, so that pupils develop a positive view of their learning and progress.
- Assessment is frequent and designed to track small steps of progress across all areas of the curriculum. EHC plan targets are closely monitored and regularly reviewed with pupils and their parents/carers.
- These standards are likely to be met if the material change application is approved.

Part 2. Spiritual, moral, social and cultural development of pupils

- Leaders have developed and implemented a carefully planned programme for pupils' social, moral, spiritual cultural development. Opportunities are identified across all areas of the taught curriculum and enhanced through the range of additional activities, visits and visitors to the school. Fundamental British values are actively promoted.
- These standards are likely to be met if the material change application is approved.

Part 3. Welfare, health and safety of pupils

- The school's safeguarding and child protection policy meets all statutory guidance and is available on the school's website. The school makes suitable arrangements to safeguard and promote the welfare of all pupils attending the school.
- The proprietor has drawn up an appropriate health and safety policy which is implemented effectively to ensure that the school complies with all relevant health and safety laws.
- Leaders have ensured that high levels are supervision are consistently in place. They have made suitable arrangements to increase the number of staff employed as the number of pupils rise over time.

- The school meets the requirements of the Fire Regulatory Reform Act 2005. Stringent measures are in place to manage the risk of fire.

- The proprietor has ensured that a single central register is in place which meets all statutory requirements. Leaders are fully aware and compliant with the checks to be made when supply staff are employed through an agency.
- All staff are trained in safeguarding, including the proprietor. Staff are also trained in how to raise and record any concerns on the school's electronic system.
- These standards are likely to be met if the material change application is approved.

Part 5. Premises of and accommodation at schools

- The proposed new school building has recently been completely re-furbished and repurposed to a very high standard and will comfortably accommodate the proposed increase in pupil numbers.
- Classrooms offer excellent resources for learning, providing specialist equipment for technical and vocational education opportunities. They are bright and airy, with good ventilation. Acoustic conditions are good. The medical room is available for sole use when necessary and can be suitably supervised.
- The design of the new building has provided three attractive outdoor spaces where pupils can play or socialise. In addition, there is a large multi-use games area for physical education purposes.
- These standards are likely to be met if the material change application is approved.

Part 8. Quality of leadership in and management of schools

- The proprietor has made sure that school leaders demonstrate the knowledge and skills to ascertain that the independent schools standards are met consistently.
- The proprietor and school leaders have identified a significant need for the additional provision proposed, across the three local authority areas that they currently serve. They are clear that this proposal will be enable then to make a more rapid response to meeting the needs of younger pupils than is currently the case. They have been proactive in looking to the future to plan for recruitment in terms of numbers, but also for the quality, experience and skills required, as they increase pupil numbers over time.

- Leaders propose to admit up to 60 pupils aged of 11 to 16 if the material change application is approved.
- Leaders have requested approval of new premises at Wellesley Street, Shelton Stokeon-Trent, ST1 4NF.
- Pupils are admitted to the school through local authorities including Staffordshire, Stoke-on-Trent and Cheshire East.
- The school does not have a religious denomination.
- The school does not use alternative provision.

- The material change inspection was commissioned by the DfE to determine whether the school is likely to meet the relevant independent school standards if the proposed material change is approved.
- The inspector met with the proprietor's representative, the executive headteacher, the head of school and deputy headteachers.
- The inspector also spoke to teachers and pupils and visited classrooms in the existing premises.
- The inspector reviewed a range of documents and considered the school's compliance with safeguarding procedures and Schedule 10 of the Equality Act 2010.
