Inspection judgements

Overall experiences and progress of children and young people: outstanding

Children living at this home are very settled and have built secure and trusted relationships with all the staff. Staff listen to and engage with the children, and this helps children to work through early childhood traumas and difficult times that they have experienced in their lives. A social worker said of the staff's approach, 'The children always come first, and the home belongs to the children who live there.'

Children are enthusiastic about living in the home and talked openly about their progress and positive experiences. Children say that they are happy and optimistic about what the future holds for them. They are involved in day-to-day decisions about their lives and their opinions are valued by staff. There is a relaxed and homely feel in every part of the property. The environment is spacious, warm and welcoming. It emulates a healthy, loving family environment where children can thrive.

Due to exceptionally detailed and considered care planning processes, children's complex needs are accurately assessed. The quality of care is unconditional, each day is a new day, and children thrive on fair but firm routines and boundaries. This has seen much progress and a significant improvement in the emotional well-being of the children.

Much thought is given to helping children to feel safe and at ease in their surroundings. The children have their own space to relax and a large games room with plenty of age-appropriate activities. Each room has pictures of the children having fun times together. This adds to a sense of belonging and permanence for the children.

Relationships with parents, siblings and friends are encouraged. Family time is promoted, and staff go that extra mile to make sure that children have good and memorable experiences. Time spent with family members and friends is appropriately supervised and balanced against developing children's independence through free time.

The registered manager and staff treat the children with trust, dignity and respect and this is reflected in how children manage their emotions more effectively. This practice is also reflected in the language used by staff and in the child-centred recording in children's care plans and records.

There is an on-site psychologist who is part of the care team. Help and intervention is accessible to children in relation to any past traumas they have experienced and any current concerns. This therapy is put in place shortly after children move in to the home. It benefits children by ensuring timely intervention and the provision of services and support that are specific to the children's needs.



The registered manager and staff promote the value of education, and the children are highly supported to attend. Staff's close working relationships with education colleagues unpick any barriers to learning. All the children are doing exceptionally well. Their attendance is close to 100% and their attitude to learning is commendable.

Children enjoy engaging in activities of their choosing, such as going to the cinema, playing football, enjoying day trips to theme parks, and attending 'Scare Fest' at Halloween as part of the wider community. This has given the children more opportunities in life, developed their confidence, and helped them to make friends.

How well children and young people are helped and: outstanding

The registered manager and staff work in partnership with professionals. It starts prior to a child coming to live at the home. Attention to detail and professional curiosity ensures that children are well matched to one another, and their care and therapeutic needs can be met at all times. Conflict between the children is extremely rare; they have their own hobbies and interests, but equally enjoy spending time in each other's company.

The safety and protection of children is a priority. Risk assessments, therapeutic interventions, and effective care planning identify the needs of children and any risks affecting them. Children participate in writing their own care plans and this supports the children to make positive choices and keep themselves safe.

All the children feel a very strong sense of safety and well-being in the home. They spoke quite openly about how safe and relaxed they feel and how staff help them to manage their emotions better. The need to physically intervene to keep children safe is very rare as children manage their emotions and feelings due to the support they receive.

Individualised and well-documented recording activity, key working, and discussions ensure that all risks and vulnerabilities are clearly understood and talked about. It supports staff's understanding of each child's individual triggers, needs, and vulnerabilities. There are firm but fair boundaries in place that are consistently applied that help to enhance the care given to the children.

Children do not go missing and, during free time, children respond well to welfare calls and checks by staff on their whereabouts. Children are helped to understand the risks associated with social media and online gaming, which results in children making more-informed choices.

Staff are highly trained in all aspects of safeguarding, and this adds to the children's sense of safety and well-being.



The effectiveness of leaders and managers: outstanding

Since the last inspection, a manager who managed the home previously was rerecruited and has now become the registered manager again. She is a confident and competent leader and creates a culture of positivity. Staff speak very highly of her and comment on her unwavering support for the children and the staff team.

Leaders and managers are proactive in ensuring a model of best practice is used. Opportunities for staff to grow and develop their practice through regular training and bitesize learning opportunities ensure consistency in their approach, which is individualised to the needs of each child.

Leaders and managers work collectively on behalf of the children across agencies. The on-site psychologist works closely with the staff, offering clinical consultation, supervision, and training alongside weekly therapy sessions with the children. This ensures a therapeutic delivery of care with an emphasis on high nurture, empathy and praise.

The home has a skilled and established staff team in place. Much emphasis is placed on the recruitment and retention of staff who have the skills, tenacity, and passion to make a positive difference in the lives of children. Staff have opportunities for continuous learning and to further their careers through promotion.

Leaders and managers have a comprehensive system of monitoring all aspects of the home. The registered manager and her deputy provide staff with regular and reflective supervision. They have good oversight of the care and progress of the children and are very hands-on in all aspects of service delivery. The children speak very highly of the registered manager and say that she is always there for them.

There is a strong emphasis on multi-agency working, and this promotes timely and effective care planning. When children are due to leave the home, they are fully prepared when the time comes. Professionals were extremely complimentary about the proactive and caring approach of the registered manager and all the staff team.
