Summary of key findings

This provision meets requirements

- The provider and staff have sound, up-to-date safeguarding knowledge, particularly within the local area. They regularly access training to help them to identify and respond to typical signs of possible abuse and neglect. The provider and staff correctly explain the local procedures for reporting their concerns, including if an allegation is made against staff.
- The provider understands the importance of evaluating the quality of service that she provides. For example, she confirms she will seek the views of children, such as their current interests, to involve them in planning of the weekly activities, and to have lots of fun.
- The provider and staff demonstrate how they will act as positive role models, support children's positive behaviour and encourage respect for one another. They confirm that all children are welcome, particularly those children who live in the local community. The provider and staff say they will ensure all children feel emotionally secure and safe, such as the youngest children will be assigned a key person to help to promote their welfare and well-being.
- The provider recognises the importance of promoting children's good health and physical exercise. For example, she confirms she will provide children with a healthy light tea every day, such as freshly cooked chicken and noodles. She describes how staff plan a range of physical activities, such as football coaching, boxing, and dance sessions, to help to promote children's physical skills and exercise.
- The provider knows that not all children have the same experiences as others. She understands the importance of providing children with many exciting opportunities to enhance their experiences, and to help to keep them engaged.

There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Information about this early years setting

YPM Childcare Provider at Stockwell registered in 2015. It operates from a community building which is located in the London Borough of Lambeth. The after-school club runs from 3.30pm to 6pm from Monday to Friday, and from 6.30pm until 8pm for children aged 11 years to 14 years of age, during term time only. There are three staff members. Of these, all hold qualifications between level 5 and level 2.

Inspection activities

- This was the first routine inspection the provider received since the COVID-19 pandemic began. The inspector discussed the impact of the pandemic with the provider and has taken that into account in their evaluation of the provider.
- The inspector viewed the provision and discussed the safety and suitability of the premises.
- The inspector looked at relevant documentation and reviewed evidence of the suitability of staff working at the club.
- Staff spoke to the inspector at different times during the inspection.
- The provider and the inspector discussed how they organise the environment, and plan suitable experiences for different ages of children.
- The inspector met with the provider and discussed the leadership and management of the after-school club.

We carried out this inspection under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
