#### Information about this children's home

This privately run home provides care for up to six children. The children may have had traumatic experiences that have left them vulnerable.

The registered manager left in January 2024. A new manager was appointed in February 2024 and is in the process of registering with Ofsted.

## Information about this inspection

At this inspection, the inspector evaluated:

- the care of children
- the safety of children
- the effectiveness of leaders and managers.

Inspectors have looked closely at the experiences and progress of children, using the social care common inspection framework. This assurance inspection was carried out under the Care Standards Act 2000 to assess the effectiveness of the service, how it meets the core functions of the service as set out in legislation, and to consider how well it complies with The Children's Homes (England) Regulations 2015 and the 'Guide to the Children's Homes Regulations, including the quality standards'.

## Findings from the inspection

We did not identify any serious or widespread concerns in relation to the care or protection of children at this assurance inspection.

At the time of the inspection, three children were living at the home. One child has recently moved to the home and has settled well. Leaders and managers have decided not to accept any more children for a period of time. This reduces the number of changes that the children living at the home experience and increases their sense of stability.

The registered manager left in January 2024. A new manager was appointed in February 2024 and has been supported by another manager and the responsible individual. Leaders and managers have worked hard to make improvements since the last full inspection. A detailed development plan is in place to improve the quality of care.

Managerial monitoring and oversight have improved. Regular checks by the managers ensure that the quality of care and practice is monitored effectively. This enables the managers to address issues and improve practice.

Staff know the children well; they recognise their strengths and ensure that children access the activities they enjoy. The staff celebrate the children's achievements and talk about them with pride. This helps to improve the children's self-esteem and confidence.

Children's risk assessments are detailed and contain risk-reduction strategies. They are regularly updated. This ensures that staff have a good understanding of the risks that they need to manage and the actions required to keep children safe.

On two occasions, the staff have called the police for support during incidents. These incidents have been well documented. Effective recording of incidents helps managers to monitor the staff's response to serious incidents and identify learning outcomes.

Staff said that they feel supported by the manager. She makes herself available to staff for advice. As the manager regularly works with the children, she acts as a positive role model to staff and has established trusting relationships with the children.

Staff support children to lead healthy lifestyles. Children's plans detail bedtime routines for staff to follow to reinforce good sleep hygiene. Staff talk to children about healthy foods and portion sizes. However, sugary snacks and other less-nutritious options are available to children. This makes it harder for children to make positive choices about their food content.



The manager has met four requirements from the last inspection. One requirement was not met and has been restated. One requirement was not reviewed as part of this visit.

a qualification which the registered person considers to be equivalent to the Level 3 Diploma.

The relevant date is—

in the case of an individual who starts working in a care role in a home after 1 April 2014, the date which falls 2 years after the date on which the individual started working in a care role in a home; or

in the case of an individual who was working in a care role in a home on 1 April 2014, 1 April 2016. (Regulation 32 (2)(a)(b) (3)(b) (4)(a)(b) (5)(a)(b))
