## Summary of key findings

### This provision meets requirements

- Staff demonstrate a clear understanding of how to safeguard the children in the setting. For example, they recognise the potential negative implications of social media and explain clearly to children the importance of keeping themselves safe online. By encouraging children to share anything that makes them uncomfortable, any concerns can be managed. Staff also know how to recognise the possible signs and symptoms of abuse and neglect and to whom to report these concerns. They conduct daily risk assessments to minimise the risks to children in the setting.
- Staff understand the importance of having high expectations of children's behaviour. For example, there are rules in the setting that must be followed, such as no kicking balls inside and using inside voices. Staff know how to support children to develop positive relationships. For instance, they incorporate sharing, turn taking and respect for others into daily activities.
- Staff recognise the importance of building strong bonds with children to promote their emotional well-being and help them feel secure. For example, they conduct weekly meetings with the children to encourage them to share their ideas about activities to plan. This helps children to build their independence as they make choices and have their voice heard.
- Staff understand the importance of encouraging children to develop a healthy lifestyle. They know how to promote healthy eating, physical activity and being outdoors. For example, children are encouraged to eat healthy snacks and staff teach children different ball skills as they build their physical confidence.
- Staff know how to build strong working partnerships with parents to help promote consistency for all children. For example, they provide detailed verbal feedback when children are collected and gain parent views about the provision. This supports a positive working partnership with parents as their opinions are valued and any concerns about children are dealt with swiftly.
- Staff understand how to create an inclusive environment. They have completed specific training to provide high-quality provision for all children, including those with special educational needs and/or disabilities.
- Leaders understand the importance of keeping staff's knowledge up to date. They do this through providing regular training and working with other settings to share good practice. They explain that this helps them to continually reflect on their practice and adapt it accordingly.

There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

## Inspection activities

- This was the first routine inspection the provider received since the COVID-19 pandemic began. The inspector discussed the impact of the pandemic with the provider and has taken that into account in their evaluation of the provider.
- The inspector looked at relevant documentation and evidence of the suitability of those working with the children.
- The leadership team showed the inspector the premises that they use for the children.
- The leadership team explained to the inspector how they meet the safeguarding and welfare requirements to keep children safe.
- Although there were no children in the early age range present at the time of this inspection, there were children present who were over the age of five years

We carried out this inspection under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
