Summary of key findings

This provision meets requirements

- The childminder demonstrates that she can provide a warm and welcoming environment for children.
- The childminder shows she has the knowledge and understanding of the learning and development requirements for the foundation stage.
- The childminder explains how she would set up her environment, so children can access resources that are appropriate to their age and stage of development. She explains how children learn through play and how she would follow their interests and plan a variety of activities that would engage them and help them to concentrate.
- The childminder demonstrates that she understands the importance of healthy lifestyles. She would provide children with lots of opportunities for physical activity in the garden, visits to playgrounds to practise gross motor skills and ensure children eat healthy snacks or engage in healthy cooking activities.
- The childminder is clear about how to monitor and track children's learning. She speaks about progress checks at two years old and sharing information with parents. Where children may need additional support, the childminder talks about referring them and working alongside professionals, such as speech and language therapists, to ensure children make good progress.
- The childminder knows about the importance of children feeling safe and secure. She explains her procedure when children start. She talks about building good bonds with children, finding out everything from parents before they start and helping them settle.
- The childminder shows how she is improving her knowledge and wants to continue to enhance her professional development with further training. She has recently been on child protection training and explains how she would identify children at risk and the procedures she would follow to keep them safe.
- The childminder talks about the importance of helping children with their language development. She explains how quality conversations and interactions are important, as well as role modelling language, so children can hear and learn new words.
- Reading and sharing stories with children is an important part of her practice and she is keen to promote a love of reading.
- The childminder shows an understanding of how to promote positive behaviours and attitudes. She talks about how she supports younger children with sharing and taking turns, using a variety of strategies and setting clear boundaries.
- The childminder talks about parent partnerships. She explains how she shares observations with parents and gives daily feedback. She ensures parents know how their children are doing and work on anything parents would like support with too.



There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
