Overall outcome

The school does not meet all of the independent school standards that were checked during this inspection

Main inspection findings

Part 1. Quality of education provided

Paragraphs 2(1), 2(1)(a), 2(1)(b), 2(1)(b)(i)

- At the school's last standard inspection in February 2023, inspectors found that the curriculums for many subjects were not well designed. In these subjects, leaders had not defined what pupils needed to know or the order that learning should take place. Pupils did not build a deep body of knowledge across a range of subjects.
- In their action plan, leaders proposed to set out the key knowledge that pupils needed to learn within the curriculum plans and schemes of work.
- At this progress monitoring inspection, leaders had made progress in setting out the overall content that they want pupils to learn. For example, leaders have identified broad topic headings such as 'the Tudors'. However, for most subjects, the finer details of the curriculum had not been finalised. Leaders had not identified the subject-specific knowledge that pupils should learn and remember. This also meant that leaders had not carefully considered the sequence of learning.
- This independent school standard (the standard) remains unmet.

Paragraphs 3, 3(e)

- At the school's standard inspection in February 2023, inspectors found that teachers did not have the knowledge or confidence to teach some subjects effectively. In part, this was because the school's curriculum did not offer them sufficient guidance. However, some teachers also lacked the subject-specific expertise to explain new learning confidently and clearly.
- In their action plan, leaders proposed to provide professional development for staff. They also planned to develop their quality assurance procedures to gain a clearer understanding of the effectiveness of the curriculum. Alongside these actions, leaders stated that they would work with external specialists to develop the subject leader roles.
- At this progress monitoring inspection, leaders had worked with external consultants to improve teachers' subject knowledge and subject leadership. However, this work was at an early stage.



- This standard remains unmet.
- The previously unmet standards in this part remain unmet.

Part 3. Welfare, health and safety of pupils

Paragraphs 9, 9(b), 9(c)

- At the school's previous standard inspection in February 2023, leaders did not consistently record behaviour incidents as accurately as they should to allow them to spot any patterns or trends in pupils' behaviour.
- In their action plan, leaders proposed to implement an electronic system to record incidents of poor behaviour and related sanctions.
- At this progress monitoring inspection, leaders had put in place a system for staff to record incidents of poor behaviour and related sanctions. Leaders use this to evaluate patterns of behaviour.
- The school meets all of the previously unmet requirements in this part.

Part 8. Quality of leadership in and management of schools

Paragraphs 34(1), 34(1)(a), 34(1)(b)

- At the school's last standard inspection in February 2023, this standard was unmet. Inspectors found that the proprietor had failed to ensure that all the standards were met. The proprietor did not have strategic oversight of the work of the school.
- In their action plan, leaders proposed to seek additional training and external support to strengthen their ability to ensure compliance with the standards. However, they did not make it clear how leadership capacity would be increased to enable the headteacher to maintain a strategic overview of the school.
- At the time of the progress monitoring inspection, the headteacher had more time allocated to maintain a strategic overview of the school. However, leaders had failed to comply with all of the previously unmet standards. They had taken positive action towards meeting the standards, but some remained unmet.



Compliance with regulatory requirements

The school does not meet the requirements of the schedule to the Education (Independent School Standards) Regulations 2014 ('the independent school standards') and associated requirements that were checked during this inspection. This included the standards and requirements that the school was judged to not comply with at the previous inspection. Not all of the standards and associated requirements were checked during this inspection.

- The previous standard inspection took place on 21 to 23 February 2023.
- The school operates from premises at 400 Bury Old Road, Prestwich, Manchester, Lancashire, M25 1PZ.
- The school does not make use of any alternative provision.



Information about this inspection

- This inspection was carried out at the request of the registration authority for independent schools. The purpose of the inspection was to monitor the progress the school has made in meeting the independent school standards and other requirements that it was judged to not comply with at its previous inspection.
- This is the school's first progress monitoring inspection following the standard inspection in February 2023.
- The Department for Education required the school to prepare an action plan. This action plan was accepted with modifications.
- This inspection was carried out without notice.
- The inspector met with the headteacher and the deputy headteacher. The headteacher is also the proprietor.
- The inspector met with some of the teachers and looked at examples of pupils' work.
- The inspector reviewed a wide range of documentation. This included information relating to the standards, the school's curriculum, leaders' improvement priorities, leaders' approach to safeguarding pupils and the checks that leaders carry out on newly appointed staff, including supply staff.
