## **Information about this children's home**

This secure children's home is run by a voluntary organisation and is approved by the Secretary of State to restrict children's liberty. The home can accommodate up to 12 children aged between 10 and 17 years who are placed by local authorities under section 25 of the Children Act 1989. There were six children living at the home at the time of the inspection.

Admission of any child under 13 years of age under section 25 of the Children Act 1989 requires the approval of the Secretary of State.

The commissioning of health services in this home is the statutory responsibility of NHS England under the Health and Social Care Act 2012. Education is provided on site in dedicated facilities.

The manager is registered with Ofsted and has managed the home since July 2022.

## **This monitoring visit**

This monitoring visit was carried out in line with the memorandum of understanding between Ofsted and the Department for Education (DfE).

Inspectors visited the home with specialist architects commissioned by the DfE. This visit forms part of the information that Ofsted provides to the DfE so that the Secretary of State can make a decision about the continuing suitability of the home to restrict children's liberty.
