## Main inspection findings

Part 3. Welfare, health and safety of pupils

*Paragraphs 7 to 7(b), 32(1), 32(1)(c)*

- The school has made sure that the arrangements for safeguarding and promoting the welfare of pupils are effective. These arrangements have regard to the most recent guidance issued by the Secretary of State in relation to safeguarding children in education.
- The school's safeguarding policy is published on the school's website. The policy is readily available to parents and carers. This policy reflects the latest guidance.
- The school ensures that staff are well trained and understand their safeguarding responsibilities. This training includes, for example, safeguarding learning related to relationships and sex education, sexualised behaviour and harmful sexual behaviour. Staff receive regular safeguarding updates. The school is aware of the potential risks that pupils may face. Staff understand the need to be vigilant and know how to respond when they are concerned about pupils' welfare.
- The school, and safeguarding leaders in particular, know pupils very well. They take swift and appropriate actions when welfare concerns are identified. Leaders work closely and effectively with other agencies and professionals to make sure that pupils get additional support when needed. The school has detailed child protection records.
- The school ensures that all safer recruitment checks are undertaken before adults start working with pupils. This information is recorded on the school's single central record. The school's approach to safer recruitment is robust.
- Pupils are taught about safety and potential risks. They learn how to keep themselves safe when in the community and when online. They learn about appropriate and inappropriate relationships in their relationships and sex education lessons. Pupils know that staff listen and do the right thing when they share any concerns or worries. Pupils say that they are safe and happy at school.
- The school has established and maintained a strong culture of safeguarding.

*Paragraphs 16 to 16(b)*

- The school has an appropriate risk assessment policy. The policy gives clear guidance to staff. The policy sets out the steps to undertake that identify potential risks and the actions to be undertaken to mitigate and reduce potential risks in different situations and contexts.
- Staff are trained to create appropriate, detailed and bespoke risk assessments. All risk assessments are reviewed appropriately. Individual pupils' risk assessments are reviewed often and regularly. These are adapted to particular changes in pupils' circumstances. Detailed risk assessments are written when pupils display concerning and inappropriate behaviours. These risk assessments are reviewed weekly.
- The school ensures that risk assessments are used effectively to promote pupils' welfare. The risk assessment policy is implemented effectively.
- The school meets the requirements of these independent school standards (the standards).

- Leaders, including the proprietor, have good knowledge and understanding of those standards checked on this inspection. They demonstrate appropriate skills to ensure that these standards are securely and consistently met.
- Leaders have nurtured and maintained a positive culture of safeguarding. They ensure that pupils are safe. They have effective systems in place to continually review the school's safeguarding policies and procedures. Leaders lead by example and actively promote pupils' well-being.
- The school meets the requirements of this standard.

## Information about this school

- Alderwasley Hall School is an independent special school.
- The school provides education for pupils aged between five and 20 years.
- The school is located on two sites. Pupils in key stages 1, 2 and 3 and pupils in Year 10 attend the site at the registered address. Pupils in Year 11 and post-16 students attend a site located at Derby Road, Wirksworth, Derbyshire, DE4 4BN.
- Pupils who attend the school have autism. Most pupils have social, emotional and mental health needs. Many have speech, language and communication difficulties. Almost all pupils have an education, health and care plan.

- Pupils travel to the school from several local authorities. Most pupils are placed at the school by nearby local authorities, including Derbyshire, Derby City and Nottinghamshire.
- The school does not use the services of any alternative provision.
- The school's most recent standard inspection took place from 12 to 14 July 2022.

## Information about this inspection

- The Department for Education (DfE) commissioned this emergency inspection due to concerns related to safeguarding.
- The DfE commissioned the lead inspector to check the school's approach to safeguarding, risk assessments and the quality of leadership and management.
- The inspection was carried out without notice.
- The inspector met with the headteacher and senior leaders. He met with the chair of the proprietor board.
- The inspection has considered the school's safeguarding arrangements, including the single central record of pre-employment checks and whether the school's safeguarding policy is available to parents. These requirements of the standards are met.
- The inspector considered a wide range of documents, including the risk assessment policy and samples of risk assessments.
