Introduction

The inspection was carried out by three Additional Inspectors.

Description of the school

Yerbury is a much larger than average primary school. It serves a socially, culturally and ethnically diverse area. Approximately 40% of pupils come from different ethnic groups. Over 20% of pupils speak English as an additional language and very few are at an early stage of learning English. The percentage of pupils with learning difficulties is below average and so is the percentage eligible for free school meals. Attainment on admission is average.

Quality of provision

Teaching and learning

Grade:

The quality of teaching and learning is outstanding and promotes excellent academic and personal development. This is because teachers are very skilful and consistent in providing pupils with challenging work to ensure that they are able to reach the highest possible standards. Pupils appreciate their teachers' efforts to raise their standards. One pupil commented 'Our teachers are very good at challenging us to work hard.' Teachers have very high expectations of their pupils' standards and behaviour and deliver the school's project-based curriculum very effectively to engage pupils in their learning. Teaching assistants have undertaken very extensive training and support pupils' learning very well, especially those with learning difficulties and those at an early stage of learning English. Teachers use computers and interactive whiteboards very effectively to support pupils' learning in all areas. This enhances their independent learning skills significantly. Excellent teaching in the Foundation Stage ensures that children develop their social and independent learning skills rapidly.

Assessment procedures are well established and used very effectively to promote learning. There are good examples of marking to improve pupils' work but this is inconsistent.

Curriculum and other activities

Grade:

The school provides an outstanding curriculum that goes significantly beyond statutory requirements and enables pupils of all abilities to progress and develop very well. The school makes very good provision to develop pupils' literacy, numeracy and ICT skills. Its project-based curriculum provides very effectively for the academic and personal development of all pupils. In a Year 2 assembly, where the project had been on Rain Forests, pupils presented their work to peers and parents, demonstrating the good connections between their work in different subjects. Circle time and drama are used well to help pupils deal with worries and problems. The school's creative arts curriculum is very strong. The investment the school makes in its music provision leads to excellent progress by pupils. This is reflected both in lessons and in musical performances in assemblies. Pupils have a wide range of clubs to go to after school, covering sports, arts and other activities. These receive high levels of participation from all groups of pupils. The school effectively monitors both the quality of this provision and the take-up of different groups to ensure equality of access.

Care, guidance and support

Grade:

The school provides outstanding care, guidance and support for its pupils. It has a thorough knowledge of the needs of all pupils. Consequently, it provides a very positive learning environment in which pupils reach high standards and develop extremely good personal skills. Pupils' progress is monitored rigorously and the school is very effective in supporting the progress of all pupils, including those with learning difficulties and those from different ethnic backgrounds. The school undertakes thorough risk assessments for all activities and visits. Pupils are encouraged to lead healthy lifestyles. Procedures for child protection are securely established and staff receive annual training to ensure pupils' safety. Induction procedures are very well established and new entrants are provided with 'buddies' to ensure that they settle quickly. Transition to secondary school is managed very well. The overwhelming majority of parents are very happy with the care shown to their children and the progress that they make.
