Introduction

The inspection was carried out by an Additional Inspector.

Description of the school

The nursery is situated in Central Peckham, in an area of high deprivation, low

employment and high levels of crime. The area is part of the borough's regeneration programme, and at present there is high mobility as families are rehoused. The community has two settled Traveller sites, and these families regularly use the nursery. There are 36 different home languages and a relatively high percentage of children with learning difficulties and disabilities and statements of special eduactional needs. Attainment on entry is very low for the majority of children especially in speech and language development. The nursery has recently been designated as a children's centre.

Quality of provision

Teaching and learning

Grade:

Teaching is good overall. Teachers and early years educators together plan well to meet the needs of all children and the learning environment is stimulating and exciting and encourages children to participate and try out new things. Staff make good daily observations of individual's interests, and carefully assess and evaluate how well they are doing. These assessments ensure that activities are matched to the children's abilities and interests, and provide good levels of challenge. However, there is no way of ensuring whether the activities adults plan to support individuals are then visited or used by the children.

Adults are adept at developing and increasing children's vocabulary. They are particularly skilled in developing children's spoken language through good role modelling and repeating back what children say to them. Children make huge gains in their understanding because the exciting curriculum and outdoor areas inspire children to find out more. There is scope for staff to make more use of displays such as number lines and alphabets to reinforce visual learning. Children with learning difficulties are very well supported as are those who are learning English as an additional language.

Curriculum and other activities

Grade:

The curriculum is outstanding. It is well-planned, rich and varied and promotes relevant and practical activities both inside and outdoors. Hands-on activities make learning fun and children are encouraged to take responsibility for their own learning. Children with learning difficulties play a full part in the nursery's activities. There is very good provision for those children at an early stage of learning English and a high priority is given in the curriculum to the development of speaking and extending the children's vocabulary.

The curriculum is interesting and fully caters for children's individual interests. It does much to foster independent learning and decision making. The quality of imaginative play is very good; adults interact very well with children and support them in learning how to take on

different roles. This is particularly effective for those children who are new to learning English and for those who have underdeveloped language skills. There is effective use of information and communication technology. Creative development is strongly encouraged; children made great gains in designing and creating models, pictures and even 'fairy wings' for their imaginative play. Throughout the year children have many good opportunities to enhance their learning through visits to local places of interest, such as museums, art galleries and the theatre.

Care, guidance and support

Grade:

Children receive outstanding pastoral care. Parents are very positive in their comments about this aspect. One commented, 'I feel so grateful and thankful for the care my child has received.' The nursery is safe and secure and staff work closely with parents to ensure their children's well being. Effective arrangements are in place to safeguard children. There are robust systems for risk assessments and they are carried out regularly.

Support for children with learning difficulties is very good. It is also good for the high percentage of children with English as an additional language. Child protection requirements are fully met. Vulnerable children are effectively looked after. There are very good links with the Travellers families who are regular visitors to the nursery. Everyone is included and valued. A healthy life style is encouraged and this has been supported through the encouragement of physical activity and healthy snacks.
