Introduction

This inspection was carried out by an Additional Inspector who evaluated the overall effectiveness of the school and investigated the following issues; the progress children make and their levels of achievement; the quality of teaching and learning and the impact of leadership.

Evidence was gathered from: school performance data and other documentation; observations of teaching and learning: evaluations of children's activities, including how they interact with each other and within their learning environment: parents' questionnaires and discussions with children, staff and governors. Other aspects of the school's work were not investigated in detail, but the inspector found no evidence to suggest the school's own assessment, as given in its self-evaluation form, were not justified and these have been included where appropriate in the report.

Description of the school

The nursery is situated in an area of social deprivation, although children who attend come from a very broad range of social backgrounds. Children attend on a part-time basis. The nursery admits them at the beginning of the term when they reach their third birthday. All children are of White British heritage. An above average proportion of children have learning difficulties and/or disabilities. The school offers extended care in the form of daily lunch for those who are due to start primary school in September.

Overall effectiveness of the school

Grade: 1

This is an outstanding nursery. It is exceptionally well led because every single member of staff is completely focused on providing the very best education for the children it serves. Children bounce in every morning full of excited expectation. They know there will be many captivating activities on offer both indoors and outside. The school has an extremely good reputation within the community and beyond and continually seeks to extend partnerships locally. The partnership with parents is extremely strong. Parents have daily opportunities to discuss any issues they may have with staff. Their views are highly valued by the school and parents actively contribute to children's profiles. Parents are delighted with the wonderful learning opportunities their children have and unanimously support the work of the school. One parent, whose views are similar those of most, writes, 'I am sure that after having such a great start to his education my son will excel at primary school.' This is one of the reasons why the nursery is so popular and children love to come.

When children enter the nursery their development is generally below that which is usually seen for children of this age. At the heart of children's success is the outstanding progress they make in their personal development. Children are genuinely kind and caring towards each other. For example, one small boy asked the girl next to him if her poorly knee was getting better. Children develop high levels of independence and are expected to care for their environment with very limited adult support. Children, who are only three and four years of age, select their activities and the resources they need and tidy away after they are finished. They eagerly sweep up sand and wash out paint pots. Behaviour is outstanding and children's knowledge about right and wrong is so clear that older children explain the rules of the nursery to the younger ones who have just started.

Children achieve exceptionally well. In every location within the nursery there are books relevant to specific topics. Children often browse, enjoying the pictures and retelling the story in their own words. They learn to write their own name and some letter sounds. Many even recognise the names of other children. The teaching method used in the nursery has resulted in children's speaking and listening skills reaching an extremely high level. This is because, each day, children explain which activities they are going to choose, the resources they need and what they intend to achieve. Mathematics is used as part of everyday life in the nursery. Consequently most children recognise shapes, count objects to 10 and recognise numbers up to 20. Children's knowledge and understanding of the world rapidly increases as they learn and play in the inspiring garden. Children thoroughly enjoy creative and physical activity, as one parent commented, 'My daughter is learning to share and is singing and dancing when she comes home.' By the time they leave for primary school, children of all abilities, including those with learning difficulties and/or disabilities, have made exceptional progress. Most children's development is then in advance of that normally seen. They are particularly well prepared in early reading, writing and mathematics to make the most of their education.

Excellent teaching by well trained, experienced and professional staff ensures that the nursery never stands still. Staff are always seeking new ideas to make learning fun for all children. A particular strength of teaching is the in-depth knowledge each staff member has about her own group of children. Staff make short, relevant notes about children's achievements throughout the session. They use this valuable information to guide and direct new learning, through well focused and appropriate talk. This is one of the main reasons why children achieve

so well. Their understanding is deepened through close and relevant adult interaction during practical, play activity.

The curriculum is exciting and so well planned that children are completely inspired to learn through all six areas, both indoors and outside. Children thoroughly enjoy learning and therefore attendance is good. In addition, children go on many visits, some near to the nursery and others further afield to extend their understanding of the community in which they live. Children have healthy snacks and good quality lunches each day. They know that eating well, running fast and washing hands are very important. The nursery ensures children learn about differences in people so they are well prepared for the multi-cultural society in which they live. The nursery analyses children's learning and adapts and successfully changes the way drama, role play and activities that promote early writing skills are presented in order to attract more boys to these activities.

Parents confirm that the nursery provides exceptional levels of care for its children. One parent writes, 'We think this nursery is excellent. We feel confident that our daughter is valued and well cared for.' Relationships are exemplary and so children are completely at ease within the family atmosphere created by the nursery. New children settle well and quickly because the excellent care begins when staff visit them in their home prior to them joining the nursery. Staff use this good opportunity to find out as much as they can about the children and encourage parents to contribute to their own child's new profile. Systems and procedures to protect and safeguard them are in place and well adhered to. Staff are very vigilant and well informed about protecting children.

Leadership and management, though modest in its judgement, are outstanding. The headteacher provides the staff with an exceptionally clear direction resulting in a strong, enthusiastic and loyal team who are completely committed to providing an early years curriculum based on meeting the individual needs of every child. Self-evaluation clearly reflects the nursery's commitment to high quality provision. The school's system to check children's progress is developing and the school is beginning to analyse information from staff to ensure that all groups of children and individuals make the progress they are capable of. The school is very well supported by governors who are extremely knowledgeable. They question its work and play a full and active part in its day to day work. This is an outstanding nursery where children achieve exceptionally well. Therefore value for money is excellent.
