Introduction

The inspection was carried out by one Additional Inspector. The inspector evaluated the overall effectiveness of the school and investigated the following issues: how well the school supports and challenges identified groups or individuals; how well the school makes use of both indoor and outdoor provision when planning the curriculum; how the school successfully develops personal and social skills. Other aspects of the school's work were not investigated in detail, but the inspector found no evidence to suggest that the school's own assessments, as given in self-evaluation, were not justified, and these have been included where appropriate in the report.

Description of the school

This is an average sized nursery school serving an area of considerable social disadvantage. The number of boys is almost twice that of girls. All children are of White British heritage and come from a wide mix of social and economic backgrounds. A smaller than average number of children have been identified as having learning difficulties and/or disabilities. Most children join the school in the term following their third birthday.

Overall effectiveness of the school

Grade: 1

This is an outstanding nursery school, which serves its local community extremely well. Parents think highly of it and are full of praise for the excellent staff. They say that their children love attending nursery because of the great variety of different activities and the outstanding level of care. Parents are very appreciative of the extended provision at lunch time and greatly value the support and excellent communication the nursery provides.

Under the guidance of an outstanding headteacher, children achieve well from a starting point, which, for most children, is below national expectations. By the time they leave, the majority of children have exceeded the levels expected for their age, particularly in personal, social and emotional development. Children make very good progress in speaking and listening skills through extensive opportunities which allow them to listen to, and use, spoken and written language. Curriculum planning is excellent, with a clear focus on the enhancement of social skills and language development. Children are excited to come to the nursery and love to learn new things. This is because relationships between staff and children are so good and because a well-planned, stimulating curriculum supports their learning well. All staff have a very clear understanding of how children learn. They are committed to doing their very best for the children in their care and as a result children feel completely safe and secure and enjoy their learning. The care, guidance and support of children is outstanding, and a strength of the school. Child protection policies and safety procedures are in place and checks are made of everyone who works in school. The school has excellent links with a wide range of organisations and agencies that support the all round development of the children well.

Teaching is outstanding. There is an excellent balance between indoor and outdoor activities and very good facilities, providing shelter for sun and rain, enable children to learn outdoors whatever the weather. There is a very good balance between activities led by adults and those that children chose for themselves. Children have opportunities to make music, control the flow of water as they make group decisions on how to best use it, as well as explore and design their own investigations using recycled material. As a result children discover that learning is an exciting activity that comes from a range of stimulating experiences. The school welcomes visitors from the local community and provides outings, such as to a local farm. The curriculum is rich and diverse. Children find out about other countries and plan their 'holiday' in the travel agent discussing where they would like to visit and making arrangements on the telephone. Festivals are celebrated; children make curries and dance to Indian music when it is Divali, experiment with using chopsticks for Chinese New Year and enjoy the Christmas story. The school has been working at ensuring that tasks are always challenging enough for the most able children, and they have succeeded well. Interaction between adults and children is of a high guality, which contributes to the very good gains that children make in the development of their speaking and listening, as well as personal and social skills. Children develop a good understanding of the need to keep healthy and the developing outdoor area helps them to enjoy energetic play. They are enthusiastic during snack time when fruit and drinks are enjoyed, whilst staff foster good social skills. There are a wide range of opportunities for children to take on responsibilities; these include children being responsible for their own actions as well as working with groups of other people, including visitors. The children are encouraged to contribute to the community and enjoy fund raising for local and international projects. Teachers encourage appropriate behaviour by guiding children to develop a sense of what is right and wrong. As a result behaviour is excellent and the relationships between children and with adults are extremely good. Attendance is above average. Children thrive in the calm and purposeful environment where all are valued and encouraged to succeed. They are confident learners who listen attentively, share and have respect for others. Children are extremely well prepared for the next stage in their education. The school is very thorough in assessing what children can do. Planning and record keeping are good and staff regularly observe children's progress in each area of learning. Teachers track this progress very closely and constantly adjust their learning to ensure that they provide the right challenge for each child. The system enables teachers to easily identify the needs of children with learning difficulties or those who have particular gifts or talents. The school works very closely with parents by keeping them up to date about how their children are doing and involving them in their children's learning. An important part of each day is selecting a book to take home and share with parents.

The leadership and the management of the school are outstanding. The headteacher, ably supported by the assistant headteacher, successfully motivates staff and has extremely high expectations. Team work is excellent and the skilled staff continually strive to develop and improve the education of the children in their care. As a result there is excellent capacity to improve. Governors provide good support and increasingly challenge the school's work. The chair of governors has a firm understanding of the strengths of the school and the areas for development but not all governors are involved as actively as they could be. The school works well with other educational establishments, for example, by providing placements for trainee nursery nurses.
