Introduction

The inspection was carried out by an Additional Inspector. The inspector evaluated the overall effectiveness of the school and investigated the following areas:

- the quality of teaching and the curriculum, and improvements since the last inspection;
- the quality and accuracy of assessment and target setting carried out by staff;
- the extent to which pupils understand and evaluate their own learning.

Evidence was gathered from parents' responses to questionnaires and discussions with pupils and staff. Other aspects of the school's work were not investigated in detail, but no evidence was found to suggest that the school's own assessments, as given in its self-evaluation, were not justified, and these have been included where appropriate in this report.

Description of the school

Oakley is a larger than average rural junior school serving an area of mainly private housing. A significant minority of pupils live a considerable distance from the school and come from outlying villages. The majority of pupils joining the school in Year 3 come from the neighbouring infant school. Most pupils are of White British heritage. A small number come from a variety of other backgrounds although none is in the early stages of learning English. The percentage of pupils with learning difficulties or disabilities (LDD) is similar to that of most schools. There are well established links with other schools and organisations, including close links with the local church.

Overall effectiveness of the school

Grade: 1

Pupils benefit enormously from the outstanding quality of education provided by Oakley Junior School. By the time they leave at the end of Year 6, pupils reach exceptionally high standards in English, mathematics and science. Despite some staffing changes in recent years, high standards have been maintained because the quality of teaching, care and support provided for pupils is outstanding. Pupils enter Year 3 with skills and abilities that are well above those expected in reading, writing and mathematics. Teachers and support staff are very committed and highly skilled, ensuring that pupils achieve extremely well in relation to their starting points. Consistently effective teaching and support help pupils of all abilities to make excellent progress.

The headteacher, senior staff and governors provide very effective leadership. They have secured excellent improvements to the school since its last inspection, particularly in providing a more extensive curriculum that is enhanced by an excellent range of after-school clubs, sports and music. Pupils very much appreciate what the school offers. Their excellent attendance rates reflect how much they enjoy school. One pupil remarked, 'There are so many things to do and we love the clubs and sports.' The large majority of parents are pleased with the school. In particular, they are happy with the way the school is led and managed and with the quality of teaching.

The teaching is very well organised and consistent. The grouping of pupils by ability for English and mathematics lessons has been particularly successful in maintaining high standards. The pace of learning is rapid, as was seen in a very challenging mathematics lesson for higher ability pupils in Year 6 when pupils demonstrated an excellent understanding of multiples when investigating large numbers. Lessons provide regular opportunities for the pupils to assess their own learning. For example, pupils record how well they are doing after a series of lessons by commenting on how much they have learned and highlighting which areas they understand well or less well. Teachers use a very good range of assessments to plan their lessons. In Year 6, for example, after marking pupils' work, the teacher adapted her planning for the next lesson to spend more time with those pupils who did not make as much progress as expected. The headteacher and deputy headteacher monitor lessons and pupils' performance closely. They set statutory targets after pupils complete Year 4 so that the staff can predict the levels pupils are expected to reach in national tests. . However, last year's test results show that the proportion of pupils that reached higher levels was much higher than expected, reflecting some inaccurate assessments of more able pupils.

The school has strong links with the church and local community. Pupils mature into responsible and caring individuals. They behave very well and their personal development is outstanding. Pupils successfully learn to take responsibility for their own actions and to care for others. They are involved in the sponsorship of a child in India and receive information about how the child is doing, as well as studying cultures and customs from around the world. The excellent links established with others schools and organisations include opportunities for pupils to visit a local special school to work alongside pupils who have physical disabilities or severe learning difficulties. The school council thrives on the opportunity to represent the views of others. .Pupils feel very safe and well cared for. Although some parents expressed concern about bullying and behaviour, the large majority feel that the staff deal with this very well. 'All safeguarding arrangements are robust and provision for pupils with learning difficulties or disabilities, particularly those who have reading, writing or communication difficulties, is outstanding. They are supported especially well by teaching assistants and the special educational needs coordinator enabling the pupils to make rapid progress towards their individual targets.

The many sports and activities provided by the school and the promotion of healthy eating enable pupils to adopt healthy and active lifestyles. They benefit from special arts projects with visiting artists in residence. The curriculum has improved exceptionally well since the last inspection. The development of writing and opportunities to research, using skills acquired from a range of subjects, as well as improvements to the creative arts, have been particularly successful in raising standards. Special projects involve excellent opportunities for independent learning and enquiry such as the recent design and production of puppets that are beautifully displayed as an exciting diorama. Pupils are prepared exceptionally well for secondary school. The acquisition of the skills of using computers, digital cameras and other technologies prepares pupils very well for the future.

Governors provide excellent support for the school and hold leaders to account for the standards achieved. The headteacher, deputy and senior staff work closely with governors and the recent introduction of the school's website has improved communication further. The school's modest evaluations of its effectiveness reflect the high expectations of all the staff. Their track record of improvement since the last inspection shows that the school is very well placed to continue improving.

What the school should do to improve further

Improve the way teachers identify and assess the performance of more able pupils so they can predict more accurately the proportion of pupils likely to achieve higher levels in English, mathematics and science.
