Introduction

The inspection was carried out by one Additional Inspector in one day.

The inspection focused on three main areas. Firstly, pupils' attendance and how the school seeks to improve it. Secondly, an investigation into the differences in attainment between boys and girls to see if boys are achieving well enough. Thirdly, whether pupils' progress in mathematics is good enough. Other aspects of the school's work were also inspected briefly. Sufficient evidence was found to indicate that the school's evaluations of its work are substantially accurate. Where appropriate these evaluations are included in this report.

Description of the school

Orchard Primary and Nursery School is larger than average. Nearly all pupils are from White British backgrounds and all speak English. The proportion of pupils with learning difficulties and/or disabilities, including those with a statement of special educational need, is below average. The proportion known to qualify for a free school meal is also below average. Children's attainment on entry to the Nursery is lower than that expected nationally.

The school has gained: the Active Mark Gold for Physical Education in 2005, accreditation for pupils' Emotional Health and Well-being in 2006, The Gold Award for Physical Education (PE) and Sport in 2007 and the Playground Partnerships Award in 2007.

Overall effectiveness of the school

Grade: 1

Orchard Primary and Nursery School provides an outstanding education for its pupils. The headteacher and staff lead the school most effectively and have built successfully on the strong foundations that already existed.

In relation to lower than normal attainment on entry to the school, pupils' achievement over time is outstanding. Consequently, over the past three years, overall standards in English, mathematics and science have been significantly higher than in schools nationally at the end of Years 2 and 6, and they continue to be so this year. This is because pupils of all abilities reach demanding targets. For example, pupils with learning difficulties and/or disabilities make exceptional progress and most reach the expected national standards in Year 6. Pupils' progress in mathematics is not significantly different from that in other core subjects, even though overall standards are marginally lower. Pupils make exceptional progress in English, mathematics and science, because the school is extremely well organised and teaching excellent. Indeed, pupils' standards of work and progress in science are a key strength of the school. There are high levels of expertise in the teaching of science and pupils find much of the curriculum particularly interesting.

The provision for design and technology and information and communication technology (ICT) has improved considerably since the previous inspection. Standards in these subjects securely meet national expectations and are at times higher. Standards are rising because subject co-ordinators have worked to good effect to raise the profile of both subjects, to improve resources and to sharpen teachers' skills. Standards in PE are also high. For example, all Year 6 pupils last year could swim 25m or more, because there is an extensive programme of swimming lessons from a young age.

Parents have noticed how well their children are performing. Of those who replied to the inspection questionnaire, virtually all agree that Orchard Primary has exceptional qualities. Typical of their comments is: 'Over this time (in school), I have been very pleased with my child's progress'.

Leadership and management are excellent. When the school decides to adopt a new policy, all work together to see it through successfully. Another key reason why the school is so successful is that subject co-ordinators are experts and they organise their responsibilities very effectively. Teachers have investigated how well boys and girls perform. Their analysis shows that there is only a small gap in boys' and girls' performances, which is closing. Governors also play their part by making checks on pupils' progress and by asking the school to justify what it is doing and why. This approach gives the school an exceptional capacity to improve further.

Pupils' standards and progress reflect the high quality of the teaching. Teachers present information in many interesting ways. In a mathematics lesson in Years 3 and 4, pupils had a series of questions and answers to match up to solve problems. They found this interesting and responded extremely well. Teachers consolidate ideas in pupils' minds very well indeed and model, for example, what a good sentence looks like or how to answer a problem in mathematics. In this way, pupils have a lead to follow and can then apply their knowledge with the certainty that they are doing the right things. Teachers have high expectations, such as that work should be well presented.

One pupil said: 'This is a friendly school'. Pupils bring a great sense of goodwill to school, a desire to be part of everything and an enjoyment of learning. Teachers foster these qualities

very effectively by involving pupils in many aspects of school life. The school council is active. It helps to set school rules and also to enforce them. This aspect is an exceptional feature, as pupils are showing a growing capacity to regulate aspects of their own school. Members of the council care greatly that their school is a happy place where everybody can get on really well. In this way, the school prepares pupils extremely well for their future lives.

Parents comment: 'Orchard is an extremely positive school, where the care of its pupils is at the heart'. Pupils' personal development is outstanding. They behave extremely well and make the most of what the school offers them. The collection and distribution of harvest gifts for the community recently was highly successful and included produce from the school's garden. Pupils have an excellent knowledge of how to stay healthy and know that exercise is very important. The curriculum is good. The school has begun to teach some lessons in topics. Pupils enjoy this approach greatly and several mentioned how interested they are in lessons, such as those about the moon landing and the sinking of the Titanic. However, subject co-ordinators recognize that close checks need to be made as the topic approach develops to ensure that the National Curriculum is taught as well as previously and that pupils' knowledge and skills develop in a proper sequence.

The headteacher, administration staff and teachers have worked continuously to improve attendance. Recent figures show that attendance has risen above the national average. The bigger success is in improved punctuality. Hardly any pupils are late, because the school has made it clear to all families what the rules are.

Effectiveness of the Foundation Stage

Grade: 1

Adults look after children extremely well and they feel secure, safe and settle quickly into new routines. Children's excellent behaviour reflects the strong personal, social and emotional programme. Children respond very well to the outdoor area, where they have opportunities to find out about things independently. Children learn the key skills that they need to be able to read, write and use numbers exceptionally well. The teaching consistently reinforces their knowledge of letter sounds in many interesting ways. Young children respond extremely well to the teaching, enjoy learning very much and make rapid progress. By the time they leave Reception, most have reached the standards expected of five-year-olds and many exceed them. Their progress is particularly strong in language activities, which are a major focus for Foundation Stage teaching.

What the school should do to improve further

- Ensure that teachers monitor the new curriculum closely for its effects on standards of pupils' work and that it fully meets the National Curriculum.
