Introduction

The inspection was carried out by two Additional Inspectors who evaluated the overall effectiveness of the school and particularly investigated:

- any differences in provision for or progress of particular groups
- the impact of gaps in the leadership team
- the effectiveness of monitoring and evaluation by governors and leaders of all that the school provides.

The inspectors talked with children and met with some staff and governors. Parts of lessons were observed, parents' questionnaires were examined and school information, including its self-evaluation, was scrutinised. The inspectors found no evidence to suggest that the school's own assessments, as given in its self-evaluation, were not justified, and these have been included where appropriate in the report.

Description of the school

The children who attend this Nursery and Children's Centre come from diverse cultural backgrounds. Some attend full-time and some attend just in the mornings or the afternoons. The largest groups are Black British and White British. Around 12% of the children are at an early stage of learning English as an additional language. A similar proportion of children have learning difficulties and/or disabilities covering a range of different needs. Through its Children's Centre, the school offers care before and after the normal school day, as well as in the school holidays. The headteacher was appointed in January 2008 but, at the time of the inspection, had been on long-term sick leave since February 2009. The deputy headteacher has been in charge in her absence.

Overall effectiveness of the school

This is a good school. Throughout both the Nursery and the Children's Centre, the Grove provides a stimulating learning environment where children feel very happy and secure. They develop well in confidence and self-esteem, readily making independent choices for themselves as they learn and develop well through purposefully planned play. As a result, children of all abilities make good progress, so that, in the words of parents, 'They come on in leaps and bounds'. From a generally below average starting point, children go on to join the Reception Year in other schools with standards that are in line with those expected for their ages in all of the areas of learning for the Early Years Foundation Stage.

It is a measure of the robustness of the leadership and management in this well run school that staff have been successful in working together to limit any negative impact of the headteacher's long-term absence. This, in turn, shows the Grove's good capacity for continued improvement. Many parents comment on how well the school has coped through its recent difficulties. School leaders' monitoring, drawing well on support from the local authority, has given leaders and governors a very accurate picture of provision at the Grove and has helped to maintain the good learning and development. Even when children are choosing activities for themselves, adults are closely on hand, offering help and posing questions that help the children to think and to express themselves more clearly. Skilled questioning, for example, helped an able boy to accurately predict whether fruit or coins would float and, in a group teaching session, some of the older children showed very good recall of what they had learned before about caterpillars, describing the different stages of their transformation into butterflies. Children enjoy joining in with counting songs, although, as leaders have themselves identified, opportunities are sometimes missed to move some of the older children from counting to calculation. Children who need extra help because of their learning difficulties and/or disabilities, or because they are new to learning English, benefit from good support that helps them to join in fully and to achieve well. Throughout the Grove, relationships are very good. Adults get on very well with the children in their charge. The children's good personal development is evident in the way children from different social and cultural backgrounds get on so well with each other.

There are comprehensive arrangements for ensuring children's safety and welfare. Parents are especially pleased with the way staff help their children to settle into what several describe as 'a safe and nurturing environment'. One wrote to explain that, 'My son is shy and found it hard to settle at first but the staff worked with us in easing him in'. Parents are united in their view that their children greatly enjoy coming to school, even though not all of those whose children attend part-time ensure that their children attend as regularly as they could. The children's enthusiasm is evident in everything they do, whether working inside with art, books or computers or learning and playing in the excellent outdoor facilities. A parent commented, 'I am very pleased to see my child being allowed to get messy and encouraged in lots of physical play'. Another parent wistfully pointed out, 'My daughter was devastated to learn she would have to leave the Grove to go to and;quot;Big Schooland;quot;!'

Key workers keep a careful track of the progress of the individual children assigned to them. Their assessments of each child's progress are comprehensive, and are used to keep parents fully informed of how well their children are doing and of what they need to focus on to move their learning on. Although these individual assessments are of very high quality, the Grove has not brought them together to identify objectively whether any particular group might be performing better or less well than others. This limits the scope for school leaders to analyse

where any changes need to be focused, for example to meet more closely the needs of boys, girls or children from a particular ethnic group.

The Children's Centre has placed the Grove at the very heart of the local community, providing high-quality support for families. Governors are rightly proud of the Grove's contribution to community cohesion, celebrating the diversity of children's different cultural and linguistic backgrounds and helping to broaden the children's awareness of other countries and ways of life.

What the school should do to improve further

• Gather individual children's assessments together and use these to more clearly identify whether any particular groups of children are doing better or less well than others.
