# Introduction

The inspection was carried out by two additional inspectors.

The inspectors evaluated the overall effectiveness of the school and investigated the following issues:

- Provision and children's progress in mathematical development.
- How well teaching extends the most able children and provides opportunities for them to record their learning.

Evidence was gathered from lesson observations and scrutiny of children's work and school documentation. Parents' questionnaires and discussions with children, governors and staff also contributed to the judgements. Other aspects of the school's work were not investigated in detail, but inspectors found no evidence to suggest that the school's own assessments, as given in its self-evaluation, were not justified, and these have been included where appropriate in this report.

#### **Description of the school**

About 60% of the children attending Goodway Nursery are from a White British background. The remaining proportion are from a range of other ethnic backgrounds. About 20% of children speak English as an additional language but very few of these are at an early stage of learning English. The proportion of children eligible for free school meals is high. The school provides Children's Centre Services for children and their families.

## **Overall effectiveness of the school**

#### Grade: 1

Goodway is an outstanding nursery which has built on the excellent work identified in the previous inspection. A parent, reflecting the views of many, commented, 'Goodway nursery is an outstanding and special place.' The inspectors fully support this view. Children make exceptionally good progress from their starting points because of high quality teaching and the wide range of exciting learning activities provided. Excellent attention to welfare and a very positive atmosphere lead to outstanding personal development and well-being for the children.

Outstanding leadership and management are at the heart of the school's success. The headteacher provides excellent leadership and direction. She is extremely well supported by other key staff. All staff are totally committed to doing the very best for the children and their parents. Staff commented, 'Everyone is a leader of learning here.' Self-evaluation is highly effective so the school knows what it does well and takes positive action to bring about any needed improvements. Effective systems to assess and monitor children's attainment and personal development are very well established. Governors have a very clear understanding of the school's work. They provide strong support and hold the school to account. The school demonstrates an outstanding capacity to improve.

Community cohesion is promoted extremely well. There are strong partnerships with parents, the children's centre and other agencies. Through careful analysis, the school has a very good understanding of the community it serves. It is particularly successful at adapting its provision in order to meet specific needs of children and their families. For example, children with behavioural and emotional difficulties receive high quality support. Different cultures and faiths are very effectively celebrated and promoted. The school is meeting the needs of all children. Parents rightly hold the nursery in high regard. Typical comments from the parents' questionnaire were, 'Teachers are wonderful'; 'My child has made amazing progress'; 'Excellent Nursery'; 'The headteacher does a fantastic job'; and 'Very impressed with Goodway'.

Children enter the school with knowledge, understanding and skills well below those expected for their age. By the end of their time in Nursery, they reach standards that are broadly in line with those expected. Opportunities for children to develop their speaking and listening successfully pervade all activities. Early reading and writing skills are promoted particularly well. Activities to promote mathematical development are effectively integrated into a range of lessons. Through the process of making cakes, for example, children recognise different shapes; they use simple measures and apply their numeracy skills to solve problems.

High quality teaching contributes considerably to children's exceptional progress in all areas of learning. Teachers and assistants have a very secure knowledge and understanding of how children of this age learn. Children are inspired, motivated and fully engaged in their learning because of the exciting activities offered. Staff provide an effective blend of structured adult-led activities and those which enable children to choose, explore and work independently. Assessment is used extremely well to plan the next steps of children's learning. Since the last inspection, the school has worked well on providing for the more able. As a result, activities and tasks are tailored to individual needs so children are challenged and their interest is sustained. Children have good opportunities to record their learning. Those at an early stage of learning English receive very effective support from an experienced teaching assistant. These children make rapid gains in acquiring English.

The curriculum is creative and exciting. It contributes exceptionally well to children's progress and makes an outstanding contribution to their personal development. All areas of learning are skilfully incorporated into appealing topics like holidays, pirates, mini beasts, growing, dinosaurs and witches. Visiting actors and a visiting musician make a valuable contribution to children's creative development. For example, the 'Butterfly Garden' performance gave children wonderful opportunities for drama, role play, singing and artwork. The quality of children's art is a real strength. Striking landscape paintings using a water colour technique decorate the corridors. Children capture the sky, trees and flowers beautifully. The school has made some old buildings an attractive and stimulating place for children to learn. The new accommodation has created additional facilities for children, staff and parents. Outdoor learning areas are used really well. Children grow a range of vegetables in the garden and the Goodway train line with its station provides plenty of opportunities for role play. Some outdoor areas and the woodland have rightly been identified for improvement in the school's plans.

High quality care and the stimulating environment enable all children to thrive. A parent wrote, 'Teachers are wonderful and very caring towards children.' Procedures to protect and safeguard children are rigorous and robust. Children thoroughly enjoy their time at nursery. As a parent wrote, 'My children have always been eager and excited to go to school.' Children participate in vigorous exercise and understand the importance of healthy diets. They choose and enjoy the fresh fruits, salads and vegetables on offer. Children relate very well to adults and their peers. They share equipment and materials. Behaviour is often exemplary because of high expectations from staff and the excellent relationships between adults and children. At Goodway, children are extremely well prepared for the next steps of their education.

#### What the school should do to improve further

Improve the learning opportunities in some of the outdoor areas and in the woodland, as identified in the school's improvement planning.
