## **Overall effectiveness**

## Grade: 3

The overall effectiveness of the learning and skills provision is satisfactory. Day-to-day operational management of education and vocational training is good although staff do not share good practice sufficiently across the provision. The quality of teaching and learning is mostly good and the achievement of qualifications is high on the majority of programmes. Lessons are purposeful and engaging, and learners make a good contribution. Assessment and verification practices are satisfactory. Records on individual learning plans are adequately maintained and appropriate targets are set. The quality of learners' work is variable, although it is good on many courses. Safeguarding arrangements for learners are satisfactory. The promotion of equality and diversity is good and interactions between teaching staff and learners are respectful. Equality training for staff and learners is thorough and learners have a clear understanding of their rights and responsibilities.

## Capacity to Improve

## Grade: 3

The capacity to improve learning and skills is satisfactory. Achievement of qualifications for learners in vocational training are satisfactory, and in some cases good, particularly on the horticulture and industrial cleaning programmes. Punctuality is satisfactory although attendance at some sessions is low and waiting lists for many programmes are long and poorly managed.

Self-assessment is well established and the development plan has clear targets. The report is mainly thorough and evaluative although some areas are overly descriptive. Quality assurance arrangements are satisfactory and arrangements for observing teaching and learning are appropriate. However, data are insufficiently used to inform improvements fully. The range of education and vocational programmes has improved, since the previous inspection, and is satisfactory. However, not enough spaces are available to ensure that all prisoners have good access to training and the scope for progression is limited, particularly above intermediate level. Employer engagement is satisfactory.
